### **OBJECTIVES:**

The contents of this subject are focused on the knowledge of Spanish Art and its connections with cultural and social context. Throughout the course, the main objective is that students master the basic concepts of this topic and know the essential aspects of Spanish Art. They will also learn the key aspects of the main artistic styles that have been developed in Western Culture.

#### **METHODOLOGY:**

The classes follow the organisation of the programme, being taught during the scheduled teaching hours. The classes have a theoretical and practical content, also using the support of all complementary material that serves to gain more in-depth knowledge of the artistic heritage of Spain. The focus of this subject is eminently practical and current, so that the practical classes will be based on the active participation of the student. Active participation in class also includes interaction on the subject's social networks (Instagram, TikTok).

Field trips to local monuments will play an essential role in the course of the lessons. It is expected that a field trip will be arranged every two weeks.

# **ASSESSMENT:**

The acquisition of knowledge and skills will be assessed by means of a written exam that may account for up to 40% of the final grade. Students will be expected to participate actively in class. There will be possibility of carrying out a research paper supervised by the teaching staff, which may increase the mark obtained in the exam.
